TREATMENT ACCOMPLISHMENTS

- Served 216 clients and 15 babies from 26 different counties (up from 18 counties in 2010)
- Graduated 30 youth with a high school diploma or GED
- Facilitated:
 - 10,472 individual therapy sessions
 - 1,990 family therapy sessions
 - 1,282 group therapy sessions focusing on issues like parenting, social skills, surviving abuse, restorative justice and gender issues

PONTIAC HOUSE GETS RE-ENERGIZED

Third Way Center's Pontiac House received energy efficient updates thanks to a *NEEP (Non-Profit Energy Efficiency Program)* grant from *Energy Outreach Colorado*. Some of the updates included insulation, weather stripping, new windows, new air conditioning units, LED exit signs, occupancy sensors for lighting, and energy efficient lighting upgrades. An estimated \$1000 a year will be saved on energy bills!

THIRD WAY CENTER WELCOMES DR. WAGNER SCHORR TO BOARD OF DIRECTORS

In 2011, Third Way Center welcomed Dr. Wagner Schorr to our Board of Directors. Dr. Schorr is a prominent, retired nephrologist in Denver who served on the volunteer faculty at the University of Colorado Health Sciences Center for many years. He was a part of the transplant team that performed the first kidney transplant in Colorado and one of the first in the world. He is a former director for the Colorado Health Foundation and the Denver Country Club. In addition to the Third Way Center board, he currently serves on the boards of Innovage, and the Arts Students League of Denver. Dr. Schorr lives in Denver with his wife, Annalee. His children are also physicians and highly acclaimed health care providers.

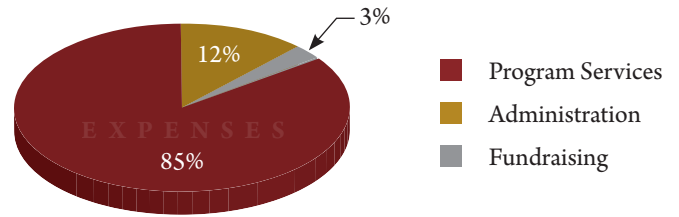
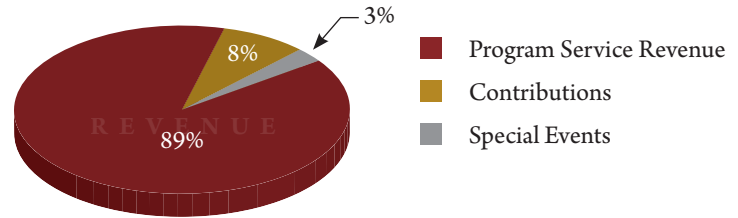
True Grit raised approximately \$230,000 for our youth and programs.



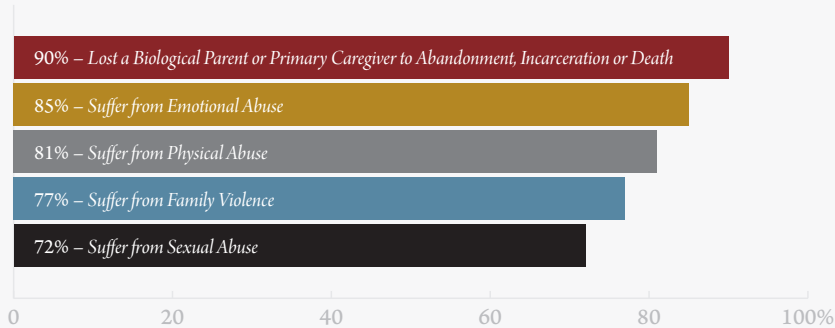

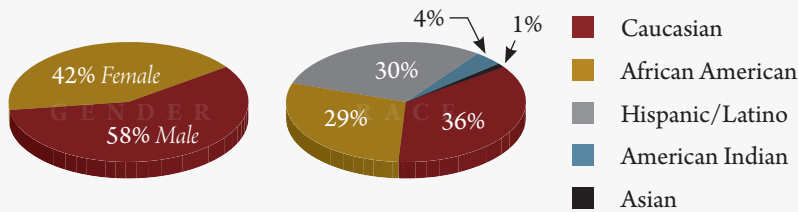
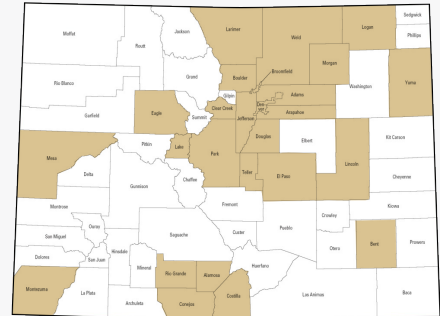
