TREATMENT ACCOMPLISHMENTS

- Served 232 clients and 14 babies from 24 different counties and 2 Native American Tribes.
- Graduated 37 youth with a high school diploma or GED.

 - 11, 660 individual therapy sessions

 - 2,004 group therapy sessions focusing on issues such as parenting, independent living skills, social skills, surviving abuse, restorative justice and gender issues.

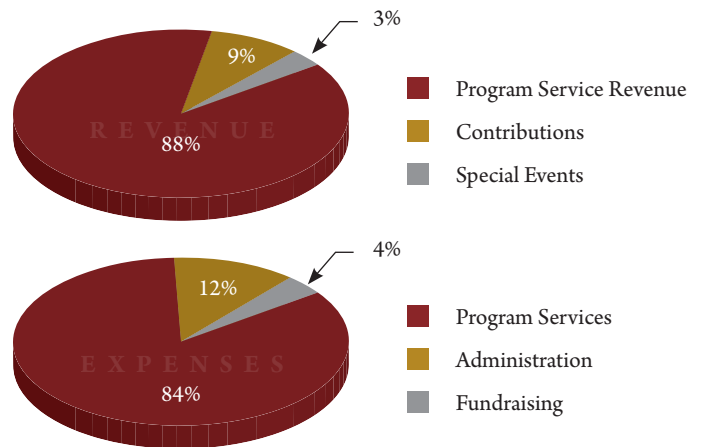
True Grit raised approximately \$273,000 for Third Way Center’s youth and programs — a record year!



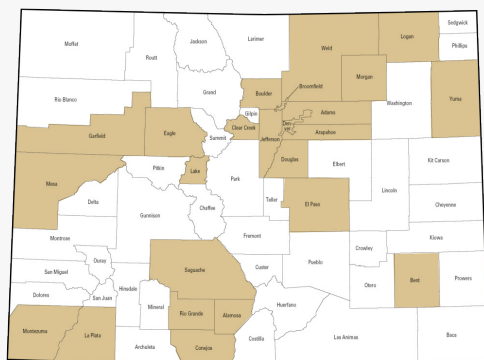
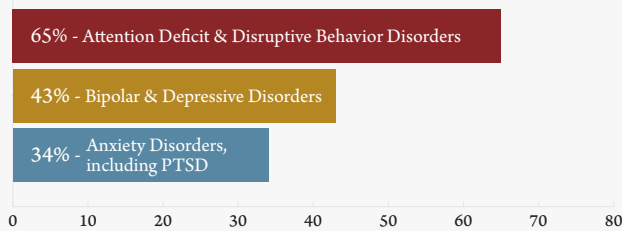

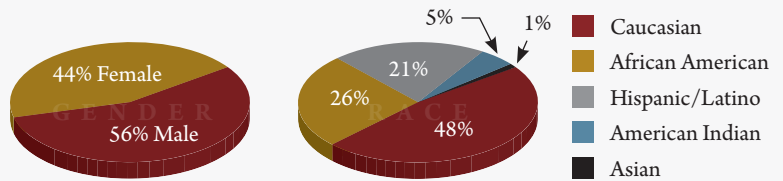
SNAPSHOT OF THIRD WAY CENTER YOUTH



The average length of stay in Third Way Center programs is **190 days**.

68% of youth who remained with Third Way Center 60 days or longer achieved their educational goals and emancipated to a sustainable living arrangement in a familial home or independent apartment in the community.

Upon entering our educational programs, Joan Farley Academy at KW Brill Center or Joan Farley Academy at Lowry, **38%** of students were behind in grade level. With the assistance of a credit recovery grant from the Colorado Department of Education, **75%** of these students were able to recover **50%** or more of missing credits – helping them work towards their high school diplomas.



In addition to the **24 different counties** depicted, we serve youth from two Native American tribes, **the Southern Ute Tribe** and **the Mountain Ute Tribe**.
